Regulation No. 170/2020 of the WUT Rector of 31 July 2020

on the launch of the Mobility Programme for Doctoral Students of Doctoral Studies at WUT as part of the implementation of the project "Excellence Initiative – Research University" at WUT

Under article 23 section 1, pursuant to article 389 sections 1 and 2 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2020 item 85, including amendments) and in connection with the Agreement No. 04/IDUB/2019/94 of 30 December 2019 signed between the State Treasury represented by the Minister of Science and Higher Education and the Warsaw University of Technology, it is resolved as follows:

§1

The Mobility Programme for Doctoral Students of Doctoral Studies at WUT, implemented in accordance with the Regulations constituting an Appendix to this Regulation, is launched as part of the implementation of the project "Excellence Initiative – Research University" at WUT.

§2

The Regulation enters into force upon signing.

The Mobility Programme Regulations for Doctoral Students of Doctoral Studies at WUT

§ 1

The purpose of the Mobility Programme for Doctoral Students of Doctoral Studies at WUT further referred to as the "Programme", is to provide the doctoral students of doctoral studies at the Warsaw University of Technology with the funding for the development of their competences through participation in brief* mobility activities, such as conferences, workshops or summer schools, among other things. The Programme is implemented as part of and funded by the Project "Excellence Initiative – Research University", further referred to as "Project IDUB (IDUB – Inicjatywa Doskonałości – Uczelnia Badawcza)", implemented at the Warsaw University of Technology pursuant to article 389 sections 1 and 2 of the Law on Higher Education and Science of 20 July 2018 and the Agreement No. 04/IDUB/2019/94 of 30 December 2019.

§ 2

- 1. Beneficiaries of the Programme shall be the doctoral students of doctoral studies at the Warsaw University of Technology in the course of the implementation of the Programme.
- 2. Each doctoral student may obtain one Mobility Package.

§ 3

- 1. The Mobility Package amounts to PLN 5,500.
- 2. The Mobility Package may be used only for mobility activities, e.g. participation in conferences, workshops, training courses, summer schools, to meet any costs incurred during the mobility, e.g. accommodation, travel expenses, allowance, conference fees and insurance. The Mobility Package must not be used as a remuneration.
- 3. The Mobility Package specifies the upper limit of mobility expenses mentioned in section 1, which can be financed by the Programme, in compliance with the rules applicable at WUT.
- 4. The Mobility Package may be used for financing only one mobility activity.
- 5. A planned mobility may also be co-financed by other sources, e.g. other mobility programmes in the Project IDUB, WUT subsidies and external financing institutions.

§ 4

- 1. The Mobility Package funding is allocated upon the request of a doctoral student in accordance with the sample application constituting an Appendix to the Regulations, containing information on the planned mobility, including:
 - 1) place, date, website of conferences, workshops, training, and summer schools
 - 2) information on the conference fee, fees for workshops and summer schools and estimated travel and accommodation expenses
 - 3) confirmation of active participation in the conference

- 4) a brief justification of mobility significance for the development of the doctoral student's competences
- 5) a positive opinion of the academic supervisor.
- 2. The application form mentioned in section 1 shall be submitted to the IDUB office no later than 14 days before the planned commencement of the mobility in question.

§ 5

The funding of the mobility is settled in compliance with the principles applicable at the Warsaw University of Technology.

§ 6

All matters not regulated herein shall be settled by the Prorector for Studies.
