Regulation No. 33/2021
of WUT Rector
of 04.02.2021

amending Regulation No. 189/2020 on the launch of the Grant+ Programme at WUT as part of the implementation of the project „Excellence Initiative – Research University” at WUT

under Article 23 section 1, pursuant to Article 389, sections 1 and 2 of the Act on Higher Education and Science of 20 July 2018 (Journal of Laws of 2020 item 85, including amendments) and in connection with the Agreement No. 04/IDUB/2019/94 of 30 December 2019 signed between the State Treasury represented by the Minister of Science and Higher Education and the Warsaw University of Technology, it is resolved as follows:

§ 1

Regulations of the Grant+ Programme at WUT which are an appendix to Regulation No. 189/2020 of WUT Rector of 10 September on the launch of the Grant+ Programme at WUT as part of the implementation of the project „Excellence Initiative – Research University” at WUT shall be replaced by an appendix to this Regulation.

§ 2

The Regulation enters into force upon signing.

The Grant+ Programme Regulations at WUT

§ 1

The purpose of the Grant+ Programme at WUT, hereinafter referred to as the “Programme”, is to raise above the minimum the amount of grant awarded to doctoral students at doctoral schools at the Warsaw University of Technology, specified in the Act on Higher Education and Science of 20 July 2018, hereinafter referred to as the “Act”. The Programme is implemented as part of and funded by the project “Excellence Initiative – Research University”, hereinafter referred to as the “Project IDUB (IDUB – Inicjatywa Doskonałości – Uczelnia Badawcza)”, implemented at the Warsaw University of Technology under Article 389 sections 1 and 2 of the Act.

§ 2

1. Beneficiaries of the Programme shall be the students of doctoral studies at the Warsaw University of Technology in the course of the implementation of the Programme and receiving grants specified by the Act, excluding implementation doctorates.
2. Beneficiaries of the Programme shall receive Grant+ from 1 October 2020.
3. Grant+ is awarded for 12 months, excluding doctoral students recruited in the summer semester of the academic year 2019/2020, who shall be awarded Grant+ for the first year of study from October 2020 to February 2021.
4. Grant+ is awarded every year upon the doctoral student’s request submitted to the Head of Management Team of IDUB Programme via Department of Doctoral Student Service, hereinafter referred to as DOD (DOD – Dział Obsługi Doktorantów), in accordance with the template of an application which is an appendix to these Regulations, after the recruitment or registration for the next year of study, respectively, in accordance with the lists of admitted or registered students submitted to DOD by heads of WUT doctoral schools.
5. The application mentioned in section 4 shall be submitted no later than 14 days after the Doctoral Student is enrolled or registered for the next year of study, subject to section 6.
6. Doctoral students admitted to doctoral schools in February 2020 submit the application mentioned in section 4 no later than 7 days after the commencement of the academic year 2020/2021.
7. Regulations on doctoral grants shall apply to Grant+.

§ 3

1. The amount of Grant+ depends on the year of study of a doctoral student and on fulfilling an academic criterion associated with the Project IDUB indices.
2. The academic criterion includes being a co-author of a scientific publication listed in TOP10, in compliance with a list published on www.badawcza.pw.edu.pl, or being a co-author of an international publication (with internationally affiliated co-authors) published within 12 months before the date of the submission of the application.

1. The amounts of Grant+ awarded in the Programme are as follows:

§ 4

Information on personal data processing

Under Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the European Council of 27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (Journal of Laws EU L 119/1 of 4 May 2016), hereinafter referred to as „GDPR”, the Warsaw University of Technology announces that:

- 1) The Administrator of the Doctoral Student's personal data is the Warsaw University of Technology with its registered seat at pl. Politechniki 1, 00-661 Warszawa.
- 2) The data administrator has appointed the Inspector for Data Protection (IOD - Inspektor Ochrony Danych), who ensures that the data are processed lawfully, and can be contacted via email: iod@pw.edu.pl.
- 3) The Administrator shall process the personal data included in this Agreement.
- 4) The Doctoral Student's personal data shall be processed by the Administrator
 - To award a grant within the Grant+ Programme at WUT– in compliance with Article 6 section 1 point a) of GDPR
 - To service the Doctoral Student's grant – in compliance with Article 6 section 1 point c) of GDPR
- 5) The Warsaw University of Technology shall not transfer the Doctoral Student's data outside the European Economic Area.
- 6) The Doctoral Student shall have the right to access his or her personal data and the right to request the correction, deletion, and restriction of data processing, the right to transfer his or her personal data, the right to object to processing his or her data, and the right to withdraw his or her consent to process their personal data at any time without giving a reason. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.
- 7) The Doctoral Student's personal data shall not be disclosed to any other subjects (administrators) except for the subjects entitled, in compliance with generally applicable laws.
- 8) Subjects (processing subjects) commissioned by the Warsaw University of Technology to perform actions which may relate to personal data processing may have access to the Doctoral Student's personal data.
- 9) The Warsaw University of Technology shall not subject the Doctoral Student to automated decision-making, including their profiling.
- 10) The Doctoral student shall provide their personal data voluntarily. Nevertheless, failure to do so renders it impossible to award funding within the Grant+ Programme at WUT.
- 11) The Doctoral Student's personal data shall be processed until the Doctoral Student's consent to process his or her personal data is withdrawn and for perpetual archiving.
- 12) If the Doctoral Student thinks his or her data protection rights as specified in GDPR have been breached, he or she has the right to lodge a complaint to a supervising body – the Polish Data Protection Commissioner.

§ 5

All matters concerning Grant+ not regulated herein shall be settled by the Vice Rector specific for the supervision on the implementation of the Project IDUB in agreement with the Vice Rector specific for doctoral students.
